#### RODENT

- 1-Burglary losses must show visible signs of forced entry and be reported to the police and facility management. Disc or cylinder locks required to waive burglary deductible.
- 2-Does not include loss due to surface waters or flooding. Flood insurance is available through the U.S. Government and the National Flood Program.
- It is the Tenants responsibility to maintain and provide a list of inventory records and documentation. This will establish a base line of Tenant inventory records and in the event of a loss, will provide the most accurate information for claims adjudication services. To simplify the process for Tenants, we created a web application tool called BirdsEyeProtection (https://birdseveprotection.com), All uploaded documentation added will be stored in a cloud-based repository at the time of submission.
